





22m working-age people say they don't know enough to plan for their retirement





Focus on Pensions




Across the UK we know:

- **£31%** of our budget is allocated to our work on Pension Guidance
- 5m of people in retirement say they are not satisfied with their overall financial circumstances
- **2.9m** of people in retirement do not feel confident managing their money
- 2.2m of people in retirement feel that thinking about their financial situation makes them anxious




